INVITATION FOR BIDS

- 1. The LG&RD District Hunza represented by Executive Engineer LG&RD District Hunza, (the "Employer") has received funds from Government of GB through GB-ADP for IMPROVEMENT/REHABILITATION OF EXISTING SEWERAGE SYSTEM AT KARIMABAD AND GANISH HUNZA and invites sealed bids from eligible bidders (Single entity or in JV) on National Competitive Bidding (NCB) procedures who can prove their eligibility and qualification as mentioned in the Bidding Documents for the works and have not been Black Listed by any Government agency/department/organization. The Bidding is open to all Eligible Bidders. The Scope of Work includes(Laying of UPVC pipe, Excavation for laying of pipe, Const. of Manholes)
- 2. The Employer invites sealed bids, under Single Stage-Two Envelope (SSTE) biddingprocedure from eligible firms or persons licensed by the Pakistan Engineering Council renewed up to 30th June 2024, in the relevant category/code for the Works.
- The bidding documents can be obtained from the office of the Executive Engineer LG&RD District Hunza located at Old Silk Road Aliabad Hunza from the date of publication till 11-03-2024 during office timings. Tender fee of Rs 5000/- (Non- refundable) in the form of Cash is required with the application for issuance of bidding documents. Bidding documents will be issued by applying on original letter-pad by owner of firms or their authorized representatives having registered power of attorney of the firm (on affidavit). No proxy will be allowed to participate.
- 4. All bids must be accompanied by a Bid Security amounting to Rs. 9,60,100/- (Nine lac sixty thousand and one hundred only) in the form of CDR from any scheduled bank of Pakistan in favor of the Executive Engineer LG&RD Hunza and is to be made part of Technical Bid.
- 5. The completed bids must be delivered to Executive Engineer Office LG&RD District Hunza at Old Silk Road Aliabad Hunza at or before1:00 PM on 12-03-2024 Bids will be opened at 1:30 PM. on 12-03-2024 at the same venue, in the presence of bidder's representatives who choose to attend.
- 6. The Employer may not be responsible for any cost or expenses incurred by the bidder in connection with preparation or delivery of the bid.
- 7. Additional performance guarantee will be governed through Clause IB.32 & sub clause 32.3 of bidding documents.
- 8. In the case of gazette /Local Holiday tender will be opened on next working day without further intimation and time completion period of the project is 24 months.
- 9. The Employer reserves the right to accept or reject any bid and to annul the bidding process and reject all bids in line with PPRA rules, at any time prior to award of Contract.
