- a) Security deposit @ 2% of the amount of bid or **Rs. 5,000/- (Rupees Five Thousand only)** for repair/maintenance of Vehicles is required to be deposited in favour of Drawing & Disbursing Officer of the Commission, Security deposits will be released/refunded within a fortnight to unsuccessful bidders and in case of successful bidders after 30th June, 2023.
- b) The Repair/Maintenance rates will be valid upto **30th June, 2023**. Sub-standard work, will not be acceptable and defaulters will be proceeded under law, including blacklisting.
- c) Only typed quotation will be accepted, use of white fluid or over writing will not be accepted.
- d) The successful bidder will be required to furnish an affidavit on stamp paper worth Rs. 20/- that the firm is not blacklisted and has no dispute with any Government Organization (s).
- e) The Competent Authority reserves the right to accept or reject any tender by whole or partially recording proper justifications/deficiency (if any).
- f) The competent Authority reserves the right to cancel the contract entirely during the currency of the year if sub-standard supply is found. The security amount will be forfeited and the firm will be blacklisted.
- g) Sealed bids, Complete in all respect may reach the undersigned on or before the stipulated time i.e. **Saturday 27th August, 2022 (Upto 1030 hours)**. Tenders/bids will be opened on the same day i.e. **Saturday 27th August, 2022 at 11:30 hours** in this Commission, in the presence of interested parties.
