1. NHA envisages to engage Operation, Management & Maintenance (OM&M) Operator(s) for OM&M contracts of above mentioned Rest Areas on advance net guaranteed revenue basis. The operators shall have a valid PEC License in operators' category O-3 or above, should be on Active Tax payer list and must have NTN and STN. The mode of procurement shall be Single Stage Two Envelope (SSTE) as defined in PPRA Rules.

2. Each Area, mentioned-above, will be awarded as a separate contract. The time period of contract for subject sites will be five (05) years.

3. On completion of contract period, the operator shall hand over all the amenities/installations to NHA in a properly maintained and operational condition without any claim to cost of repair/maintenance.

4. The bidding document comprising detailed terms & conditions, scope and bidding form, can be obtained from the office of General Manager (Rev-RoW) NHA-HQ, Islamabad during office hours after **Wednesday, 12th January 2023** by depositing Rs. 2,000/- (non-refundable) in form of pay order in favour of NHA Road Maintenance Account, Islamabad. 5. In respect of above, a Pre-Bid Meeting is scheduled to be held on **Thursday, 19th January 2023 at 1130 hrs** in NHA Auditorium, Islamabad.

6. The bid(s) for each site, complete in all respects, is to be submitted separately on or before **Tuesday, 31st January, 2023** at or before **1100 Hrs** in NHA Auditorium, Islamabad. The Technical bids will be opened on the same day at **1130 Hrs**.
