This invitation for e-Bids is open to all Bidders, meeting the following requirements:

- Registration with PPRA, including the use of EPADS, and the Pakistan Engineering Council (PEC) renewed for the year 2024-25 for the financial categories and codes specified for each work. The bidder must demonstrate five (05) years of experience in the field of construction as per the required registration category and codes of the Pakistan Engineering Council (PEC).
- A Bidder shall be a natural person, private entity, or government-owned enterprise who is active tax payer with FBR, KPRA, Sale Tax, excluding Joint Venture.
- The Bidder must have successfully completed at least two (2) Civil contracts for each NCB within the last five (5) years of the same nature and scope. The value of each contract, work order, or revised amount of the completed project should not be less than Fifty percent (50%) of the estimated cost of the project mentioned. The Bidder shall provide relevant work orders, contract agreements, and completion certificates with the e-bid.
- The Bidder shall have to provide the following duly certified/audited financial record for the last 03 years from a recognized firm registered with Institute of Chartered Accountants of Pakistan (ICAP).

Description
Average Annual Turn Over (AATO) in (PKR) @70% of the estimated cost for each NCB.
Financial Resources/Cash flow (PKR) @30% of the estimated cost in PKR for each NCB.

- National Competitive Bidding (NCB) will be conducted in accordance with **Single Stage Single Envelope e-bidding method**.

- Tender cost/fee non refundable @ Rs3,000.00 (three thousand only) for each NCB shall be deposit online to ABL, bank, A/C No.0864-001000-1691250469 of Project Director (GSC) PESCO Peshawar before bid closing time, original bank receipt should be attached with 3% original CDR.
- The prospective bidder shall submit 3% as Bid Security for each project of the estimated project cost in the form of a CDR (Original sealed Copy) from any scheduled bank of Pakistan, in favor of Project Director (GSC), PESCO Peshawar, before bid closing time, failing which the e-bid shall be considered 'non-responsive' and rejected.
- The bidder who quoted a bid (-10%) below or lower the engineered estimate shall also submit an additional 02% Bid Security of the estimated cost with e-bid for each project, in the form of CDR (Original sealed Copy), failing which the bid(s) shall be considered 'non-responsive' and rejected.
- All the interested Bidders are directed to apply through E-Pak Acquisition & Disposal System (E-PADS) portal online (<http://www.eprocure.gov.pk>) as per procedures laid down in the regulations of PPRA as per following date and time mentioned below in the office of Project Director (GSC) PESCO Peshawar.
