

Executive Engineer B&R Division GB PWD Ghanche, a public works Department of Gilgit Baltistan invites sealed expression of interest (EOI) under single stage two envelope bidding procedure from well reputed and experienced consultant firm/ consultants of engineering services registered with Pakistan Engineering Council in relevant code and category renewed of current financial year for the following consulting service:-

Prospective eligible bidders may after payment of price as per Rule 19(2) of GB PPRA along with written application properly diary and dispatch numbered may obtain personally or through authorized representative with duly attested power of attorney, a set of bidding documents immediately after the advertisement published in the newspaper etc. The said application shall be mandatorily accompanied with the following documents failing which, it shall be treated as non-responsive and summarily rejected.

- i. PEC valid registration for CFY with relevant category and code.
- ii. Latest profile of the consultant firms/consultant.
- iii. Renewal receipt GB-PWD for CFY(2023-24)
- iv. Affidavit for no sick project in hand from any department.
- v. CNIC of the prospective bidder / firm.
- vi. Certificate in the form of Affidavit of No delayed project / court case/litigation with any department.
- vii. Bid security as specified in shape of CDR from any scheduled bank.
- viii. Consultant firm/consultant must have a bank transaction for last one year of at least 30% of the value of the project cost or have bank credit line of at least 50% of the project cost.
- ix. In any case JV is not allowed.

**ELEGIBILITY CRETARIA: -**

- X. Bank statement should be properly stamped and signed by the concerned bank manager.
- xi. The TOR, qualification and evaluation criteria is enclosed with the bidding documents. All the bidders are directed to fill the form duly certified on an affidavit on a judicial stamp paper of Rs.100/-.

3. The call deposit in shape of CDR provided by the bidder along with the bid will be verified prontele art bark prior to acceptance of the technical bid by the concerned authority, bid security shall be as specified in the NIT.

- 4. The pre-bid meeting will be held in the office of the Superintending Engineer GBPWD Ghanche Circle Camp Office at Khaplu on dated 04-03-2024 at 11:00am prior to submission of queries by prospective bidder if required.
- 5. No bid shall be accepted beyond closing of time as mentioned against each work.
- 6. In case of any deviation, conflict in bidding procedure the provision of PEC &GB PPRA rule shall prevail.
- 7. All terms and condition of procurement process guidelines issued by Works Secretariat vide notification NO. Sec-SO-D-9(28)/2022-23/475 dated 26<sup>th</sup> January, 2023 and PEC bidding documents shall be part of procurement.
- 8. In case of gazetted holiday/ local holiday bid will be opened on next working day without further intimation.
- 9. Overwriting on bidding documents is not allowed and in case of any overwriting / omission is found the bid shall be rejected.
- 10. Technical and financial bid shall be opened by the procurement committee constituted by Works Secretariat.
- 11. Signing of all pages of bidding documents integrity pact and self evaluation checklist shall be mandatory failing which the bid shall be treated as non responsive and summarily be rejected in the initial screening phase.
- 12. In case of any conflict, GB PPRA Rule amended in clauses of PEC Standard bidding documents Planning Commission project manual, public financial management act 2019 shall prevail, in any case GB PPRA rule 2022 shall be major rule having over riding effect on all rules concerning procurement.
- 13. Bid validity period shall be 120 days after the date of opening of the financial bid.
- 14. Clarification of bids shall only be allowed in accordance with GB PPRA Rule standard bidding documents relevant clauses.
- 15. Performance guarantee shall be @10% of the contract amount
- 16. Bids shall be opened in the office of the Executive Engineer, GBPWD B&R Ghanche by the procurement committee.
