2. Application should be accompanied by a copy of CNIC, certificate showing class, category and field of specialization (Civil works) having valid Registration in category C-6.
3. Each Tender must be accompanied with a deposit at call / pay order for an amount of Rs. One Lac (Rs. 100,000/-) as Bid Security in shape of Deposit at call / pay order in favour of EHFPRO (Pvt) Ltd from any scheduled Bank of Pakistan.
4. Tender Notice is also available at PPRA website.
5. Tender's rates based on item rates and amounts should be filled in figures as well as in words and Tenders should be signed.
6. Conditional Tenders and Tenders not accompanied with deposit at call amounting to Rs. 100,000/- shall not be entertained.
7. The submission of Tenders by the Contractor implies that he is fully conversant with the site of work, scope of work, water and electricity availability position and terms & conditions laid down in the Tender.
8. The work shall be executed in accordance with BOQ item, Design/drawings, Consultant specifications and on approval of the Engineer Incharge.
