

Tenders will be issued to the proprietor of the Firm / Company or their legally authorized representatives having registered power of attorney (duly attested). The tenders in sealed cover should be dropped in the tender box kept in the office of undersigned on **28.04.2022** upto 01:30 P.M. The respective tenders will be opened on the same day at 02:00 P.M. in the presence of contractors or their authorized representatives, having registered power of attorney. Other terms & conditions can be seen in the office of the undersigned during office hours on any working day.
