TENDER NOTICE

SUPPLY OF ARMS FOR SPECIAL PROTECTION UNIT (SPU) GIGLIT- BALTISTAN

Special Protection Unit (SPU) of Gilgit-Baltistan Police Department invites sealed bids based on PPRA Rules 2004, from well reputed and financially sound firms having previous experience as well as registered with Income Tax and Sales Tax Departments, for the purchase of following stores/items for the Financial Year 2020-21. Bids are to be addressed to the Senior Superintendent of Police SPU, Government of Gilgit-Baltistan, Gilgit and bids should be submitted on 30th April, 2021, before 1130 hours that will be opened at 1200 hours on the same date:-

1.	SMG (Chinese Folding) 7.62 mm or equivalent along with accessories.	590	1 unit
2.	Glock-17 Gen-4 9x19 Pistol or equivalent along with accessories.	50	1 unit
3.	Pistol 9mm (ST-9) or equivalent along with accessories.	100	1 unit

2. The bids shall be received under "Single Stage- Two Envelope Procedure as per PPRA Rules, 2004. The bids shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the " **Technical Proposal**" and the " **Financial Proposal**". The following documents/ information should be attached with technical and financial proposal noted against each:-


i. Technical Proposal:

Bidding documents, will be attached (Complete specification detail of respective offered item with name of offered model on the firm's letter head pad along with catalogues, authorization certificate from the manufacturer, Sales Tax and Income Tax certificates etc.).

ii. Financial proposal:

Rate of respective item including all taxes/charges whatsoever, as per following format on the firm's letter head.

3. Technical Proposals will be opened on 30th April, 2021, at 1200 hours, while the Financial Proposal shall remain (in sealed form) in the custody of the Police Department Gilgit-Baltistan and would be opened after receipt of the technical evaluation report, in the presence of responsive bidders. The Financial Proposals of bidders found technically unacceptable, non-responsive shall be returned unopened to the respective bidder(s).
4. Rates quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges as well as inclusive of package/freight till delivery at SPU Stores/Items Gilgit (FOR) and shall be valid up to 30-06-2021.
5. The bidders shall furnish a bid security @ 5% of the bid cost in the shape of Pay Order/Call Deposit/Bank Draft of any scheduled Bank in favor of the DIG Police HQ/PD SPU, Government of Gilgit-Baltistan which will be refundable after final delivery of contract items. Proposals without bid security shall be rejected.
6. The successful bidder shall deposit equal to 10% of the total cost of store/item as performance guarantee in the form of Call Deposit/Bank Guarantee of the Scheduled Banks in favor of DIG Police HQ/Project Director SPU Gilgit-Baltistan within the period specified in advance acceptance of tender. Performance guarantee shall be returned on successful completion of the contract.
7. Special Protection Unit (SPU) of GB Police Department will not be responsible for any cost or expenses incurred by the bidder(s) in connection with the preparation and delivery of bids and subsequent presentation/demonstration of their samples.
8. The Tender Committee reserves the right to reject or accept Technical/Financial bids as per terms and conditions laid down in the bid documents.
9. The interested firms are informed that the bidding documents containing terms and conditions, standard specifications of respective item etc. are available and can be obtained from the office of the SSP HQ SPU, Gilgit by hand on written request on the firm's letter head pad @ 1000/- (non refundable). In case of public holiday, the date of receiving and opening of the tenders will be on the next day.
