- 1. The Health Department Baltistan invites sealed bids from the Pharmaceutical Manufacturers / Sole Agents of Foreign Manufacturers & their sub-distributors for procurement of Pharmaceutical items (Drugs/Medicines), Lab Items/Regents, Dialysis Kits, IV Fluid, Consumable items, Surgical items, Dental Material etc for all Health Facilities of Baltistan Region under the regular and development budget during the financial year,2024-25 on free delivery to Consignee's end basis at Baltistan Division. Detail specifications are given in the bidding documents (RFP).
- 2. Interested bidders may get bidding documents & detail specification from the office of Health Directorate Baltistan, Skardu on submission of written application on their letter head and a copy of CNIC alongwith payment of non-refundable prescribed tender fee.
- 3. Bidding documents including detailed specifications, terms & conditions shall be issued up to 6th August, 2024 during office hours.
- 4. Bidding shall be conducted through Single Stage- one envelope procedure as per GBPPRA Rules 2022 Clause 39 Section (a).

If the date of opening is observed as National or local public holiday, the bids will be opened on the next working day at same time and place.
