2. **AGPR(SO) Gilgit** hereby invites sealed bids from the original manufacturers/authorized dealers or reputed stationers/firms/suppliers Vehicle repair workshops duly registered with relevant authorities for supply of the above mentioned **“items & goods/products & Services”** to AGPR(SO) Gilgit Konodass at Gilgit. **Single Stage One Envelop Bidding Procedure** of Principal Method of Procurement i.e (**Open Competitive Bidding**) will be used by adopting **Least Cost Based Selection (LCBS) Technique** for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time).

3. Interested eligible bidders may obtain the complete set of bidding documents containing list of items, specifications, quantities and other details/description of required items and detailed terms & conditions from AGPR (SO) Gilgit Konodass Gilgit during office hours i.e. from 8.30A.M. to 4.50 P.M. during working days i.e. from Monday to Friday. 4. i-For serial No.1, bidder should have 5 year experience with successful completion of 3 contracts of stationary worth Rs.500,000/- each year during last five years. (Certificate / copies of work order needed). **For Cartridges (Inject and Tonner Printers) authorized dealership certificate should be required.**

ii. For serial No. 2, bidder should have proper workshop with 5 year experience of repairing Toyota Jeep1985 model & Toyota hilux 2007 model vehicles with successful completion of 3 contracts of repair of similar vehicles worth Rs.500,000/- each year (Certificate / copies of work order needed)

5. Sealed bids (as prescribed in Bid Data Sheet of the Bidding Document) in accordance with the provisions of Rule 36(b) of Public Procurement Rules, 2004 and terms and condition defined in the bidding document, supported by earnest money **Rs. 30,000 (Eighty Thousand Only)**, for serial No.1 & **Rs.20,000/-** for serial No. 2. in the shape of pay order/demand draft/ call deposit/banker's cheque in the name of Deputy Accountant General Pakistan Revenue (SO) Gilgit should reach the **AGPR(SO) Gilgit, KIU, Road Konodas Gilgit** on/or before 1100 hours by **1st September, 2024**. Bids will be opened on the same date at **1130 hours** in the presence of the bidders or their authorized representatives, who may choose to be present. Separate envelopes should be used for serial No. 1 & 2 serial envelopes clearly mentioning Bids for stationary & miscellaneous items for serial No. 1 and Repair of vehicles for serial No.2

In case opening date(s) is declared as a Public Holiday by the Government, the next working date shall be deemed to be the date for submission and opening of tender(s) at the same time and place. **AGPR(SO) Gilgit** may reject all bids at any time prior to the acceptance of a bid by invoking rule 33 of Public Procurement Rule (PPR), 2004.
