- c) Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: part 1 "Technical Quotation without Price" and Part II "Commercial Quotation with Price". Both technical & commercial offer should be placed in 3<sup>rd</sup> envelope.

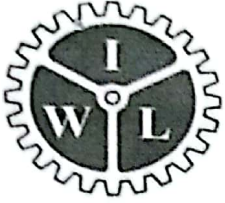
