TERMS & CONDITIONS: -

- 1. The tender rates/offer will remain valid till **30-06-2024** from the date of opening of tender.
- 2. Tender process will be completed through single stage two envelope procedure.
- 3. The rate of each item should be quoted on the basis of F.O.R District H.Q basis (i.e., Diamer Chilas).
- 4. The suppliers must have their own setup (drugs and medicines) in GB.
- 5. Bidder will provide their Form-C, Registration, Drug sale license, original affidavit regarding non-black listed, relevant experience certificate and bank statement of last one year (minimum credit transaction should be of Rs. 01.000 million).
- 6. Incomplete bids where details with complete specifications etc. if not mentioned will be rejected.
- 7. Delivery time will be maximum 04 weeks from the date of issue of supply order. In case of failure to complete the supplies within stipulated time, total earnest money will be confiscated in favor of the state & supplier will be black listed. (Contractors/Firms will provide original affidavit paper duly attested to ensure supply within 04 weeks' period)
- 8. Tender awarded on the basis of Lot.
- 9. **3**% bid amount as call deposit (CDR) from any schedule bank including KCBL in the name of Deputy Director Livestock & Dairy Development Diamer may be attached with the Technical Bid, the amount will be verified/vetted.
- 10. No bidder shall be allowed to alter or modify his bid after the bids have been opened. However, the procuring agency may seek and accept clarifications to the bid that do not change the substance of the bid.
- 11. After acceptance of the bid, a separate agreement deed on registered stamp paper has to be undertaken between the successful tenderers/Suppliers & Department of Livestock Dairy Development Diamer.
- 12. Income tax would be recovered from the suppliers as per Govt. Rules.
- 13. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request, communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- 14. Provision of Bill warranty will be responsibility of the supplier.
