LETTER FOR INVITATION

GEPCO invites sealed bids as per PPRA rules from reputable registered Security Companies, which are License Holder from Govt. of Pakistan / Punjab, Ministry of Interior Islamabad for providing security guards retired from Pak Army fighting & supporting arms mainly GD trade, Rangers, FC and Mujahid Active Force at different Installations/Offices/Buildings/Properties of GEPCO located at district of Gujranwala, Sialkot, Narowal, Hafizabad, Gujrat, M.B. Din and Bhimber.

General Terms & Conditions

- The security agency must be member of the All Pakistan Security Agencies Association (**APSAA**).
- The security agency must have updated **SECP** Company Registration Certificate.
- The agencies must have their Regional Office at Gujranwala established with address, contact and fax Nos in the service area of GEPCO and Branch offices at Gujrat and Sialkot Zones or any other city of Gujranwala Division.
- Existing strength of Security Guards must be at least 5,000 (five thousand) numbers.
- The security agency must have minimum 2000 weapons registered with computerized license including 300 AK-47. Agency must have valid license issued by Ministry of Interior, Govt. of Punjab for weapons and license for wireless equipment from PTA.
- The security agency applying should have sound financial position with at least **800 million** turn over per annum. It must be able to pay salaries for at least 3 months from its own equity / sources.
- Security agencies are required to submit single stage two envelopes for Technical bid and Financial bid in separate sealed envelopes as per PPRA Rules 2004 amended to date.
- The security agency must have experience of providing security services for at least two years to minimum 5 (five) Government departments / Entities during the last 05 years having minimum 50 guards. Give evidence.
- The Agencies / Bidders will be evaluated and selected according to the evaluation Criteria mentioned in the bidding documents (Technical & Financial).
- The Tender documents (containing whole relevant information) may be obtained from the office of Addl. Director (Security) GEPCO HQs G.T. Road Gujranwala at the cost of Rs. 3000/- during the office hour's upto 1500 hrs. No tender document will be issued on 19.03.2024 (Tuesday).
- Tender document duly sealed and super-scribed as "**Tender for Provision of Security Services**" must be delivered in the office of Addl. Director (Security) GEPCO HQs, G.T. Road, Gujranwala on 18.03.2024 upto 1600 PM. The same will be opened at 1130 on 19.03.2023 in the presence of representatives of the companies, who may like to attend. In case of late submission, Tenders documents will not be entertained.
- Each tender must be accompanied by bid guarantee of **Rs.5,000,000/- (Rupees five million only)** in the form of Bank Draft or CDR payable at Gujranwala in the name of **Chief Executive Officer, GEPCO HQ, 565-A, Model Town, G.T. Road Gujranwala** otherwise tender will not be entertained.
- The Bids should remain valid for 120 days and bid guarantee should remain valid till 150 days from the bid opening date.
- GEPCO reserves the right to reject all bids without assigning any reason and as per clause 33 (1) of PPRA Rules 2004.
- Response to this invitation does not place any obligation on GEPCO to consider any bidder for award of contract or acceptance of any tender.
- GEPCO may reject all Bids or Proposals at any time prior to the acceptance of a Bid as per Rule 33 of PPRA Rules, 2004 amended to date.
- CDR / Bank Guarantee of bid security shall be kept in Technical Proposal envelope otherwise bid will be rejected & declared Non-Responsive.
