

A complete set of bidding documents may be obtained by any interested and eligible bidder on submission of written application a non-refundable fee mentioned above against each work. The bidders acquire the bidding document from the office of the Executive Engineer LG&RD Kharmang during the office hours.

- Valid license of Pakistan Engineering Council renewed up to 30th June 2024 in relevant category and field of specializations.
- A complete set of bidding documents containing detailed terms and conditions may be purchased by an interested eligible bidder on submission of a written application on original letter head on production of bid security (2%) and original CNIC from the office of the undersigned.
- In accordance with PPRA rule-25 2004, Bid Security as indicated is required in the shape of CDR, Bank Draft or Bank Guarantee in favor of the undersigned by any scheduled bank in Pakistan, dully mentioned the name of work and title of the firm otherwise call deposit will not be accepted. The CDR of KCBL will not be accepted.
- Conditional/incomplete and lump sum bid will be straightly rejected.
- No bidding document will be issued through post, telegraph or e-mail and on the day of opening the undersigned in accordance with PPRA rule-33 of 2004 may reject all bids or proposals any time prior to acceptance of a bid or proposals.
