



TENDER NOTICE

Sealed tenders are invited for supply of IT equipment from well reputed Government Registered contractors/ firms/ companies having an updated validity with sufficient experience in supply of IT Equipment to Educational Institutions of Gilgit-Baltistan for the FY 2021-22.

Detail of equipment and financial terms and conditions are available in the bidding documents.

- 1 Interested bidders may submit their bids in the office of the undersigned upto 28th April, 2022 at 11.00 am, which will be opened on the same date at 11:30am.
- 2 The bidder may obtain bidding documents from this office on any working day before closing hours up to 27th April, 2022 on payment of non-refundable amount of Rs. 2000/- (two thousand only).
- 3 As per PPRA rules 2004 2% call deposit (CDR) of bid amount from any scheduled Bank including Karakorum Cooperative Bank Limited may be attached with the Technical Bid/Tender. In case CDR not attached with Technical Bid the Firm/contractor will be declared as "non responsive".
- 4 Successful bidders will have to submit 10% performance security of total bid price in shape of (CDR) from any scheduled Bank including KCBL within 07 days after bid acceptance.
- 5 IT equipment will have to be supplied at respective District Headquarter in GB. Rates will be inclusive of all relevant fares, transportation, taxes etc.
- 6 Single stage two envelope bidding procedure will be adopted for competitive bidding as per PPRA Rules 2004 clause 36(b).
- 7 Black listed, pending liabilities against the contractors Firms/Companies and whose registration/renewal is not upto date, will not be eligible for participation in the bidding process.
- 8 The bidder must have their own shop or outlet in Gilgit-Baltistan. Preference will be given to bidders having approved dealership/distributor of ISO certificate manufacture of IT equipments.
- 9 The tender will be on item-wise. Contractors/Firms /Companies can apply having relevant professional experience fulfilling all above terms and conditions.
- 10 In case of any dispute the decision of the Purchase Committee already constituted will be considered final.
- 11 Education Department GB reserves the right to accept or reject any or all tenders assigning reason thereof.
- 12 The tender invitation is also available on PPRA web-Site www.ppra.org.pk Islamabad.
- 13 On the date of Bid opening only "Technical proposal" will be opened whereas the envelope marked as "Financial Proposal" will be retained in the custody of the procuring employer till finalization of Technical Bids. Financial bid of qualifying Firms will be opened after finalization of Technical Bid.
- 14 The firm/company will present the sample of IT equipment to the procurement committee during opening of technical bid. Shortlisting will be made subject to approval of the sample of the firms/companies.
- 15 Rate assessment will be made based on unit rates quoted by the contractor/Firm and quantity required to be purchased.
- 16 Quantity of required items can be increased or decreased.
