## The terms and conditions for subject auction are as under:-

- 1. Each bidder will have to deposit a Bank draft / pay order worth Rs. 1,000,000/- in favour of Cantt Executive Officer along with copy of CNIC before participating in the auction proceedings as earnest money.
- 2. Pay orders of the bidders except 1<sup>st</sup> and 2<sup>nd</sup> highest bidders will be returned after completion of auction.
- 3. The successful bidder will deposit amount equal to 25 % of the bid money (non-refundable security) at the fall of hammer.
- 4. The bidder will be required to deposit remaining 75 % of the bid money (non-refundable security) and execute tenancy agreement at his own cost within thirty days of approval of the bid.
- 5. In case of failure of the successful bidder to deposit the above 75% amount due against him and execute agreement as mentioned above, the 25% amount already deposited will be forfeited towards Cantt Fund and the bidder will have no claim over the said amount. In such case, the 2<sup>nd</sup> highest bidder can be offered to deposit the dues as above and take over the possession of the building. In case of acceptance of offer, clause 3 & 4 above will be applicable upon him.

- 6. Deposited non-refundable security shall not be refunded in any case after expiry of the tenancy agreement or cancellation of tenancy agreement in case of violation of its terms and conditions by the successful bidder.
