RE-INVITATION TO BID

The Executive Engineer, Central Civil Division, Pak PWD, Mirpurkhas, situated at House No.B-15 Satellite town Phase-II, near A.J College invites sealed tenders, on percentage rate basis for the works tabulated hereunder, from the Contractors / Firms registered with Income Tax (who are Active on Taxpayers List & non-defaulter of Federal Board of Revenue & Sindh Board of Revenue) & having valid licence of Pakistan Engineering Council, in appropriate category & field of specializations.

A complete set of Bidding Documents containing detailed terms and conditions may be purchased by an interested eligible bidder on submission of a written application on original letterhead supported with requisite documents i.e. :- (Copy of CNIC, Pakistan Engineering Council Certificate, NTN Certificate issued by the Federal Board of Revenue and SRB Certificate issued by the Sindh Revenue Board) from the office of the undersigned **latest by 02.01.2023** upon payment of a non-refundable fee as shown against each in cash. However, bidders will submit sealed envelope with mandatory documents, so as to reach the office of the undersigned **on 03.01.2023 till 09:30 a.m.**, which will be opened at **10:00 a.m.** on the same day in the presence of bidders/representatives who choose to attend at the same address.

In accordance with PPRA Rule-25; Bid Security as mentioned against each work is required, in shape of call deposit/bank guarantee in favor of undersigned, duly mentioned the name & title of the firm by any schedule bank. The bidder will submit original bid cost along with bidding document otherwise it will treated non-responsive.

Terms and Conditions

1. Separate Application on Firm's Original Letter-Head for each tender document shall be admissible.
2. Tender documents shall be issued only to owner or authorized representative of the firm. Registered power of attorney will be required in case of representation of the firm by the person other than its proprietor.
3. Copy of all mandatory documents must accompanied with the bidding documents i.e. valid CNIC, National Tax Number certificate issued by Federal Board of Revenue, SRB Registration Certificate, Pakistan Engineering Council licence in the relevant category / fields of specialization. Failure will tantamount to substantially non-responsiveness of the bid(s) for further evaluation.
4. Tender documents shall not be entertained if received incomplete/conditional, received by mail/courier, fax or telegraphically.
5. All CDRs once received, would be credited into government account and returned through government cheque. In addition to this, the original bid security i.e.: Call deposits/bank guarantee of 1st, 2nd and 3rd lowest bidders will be retained till acceptance of tender. (If required)
6. In case the lowest bid cost is found abnormal below; the bidder will have to furnish additional performance security in the form of Call Deposit, Bank Draft of an amount equal to the minus (-) variance with reference to Engineer's Estimate / Estimated Cost, otherwise, the bid security will be forfeited and necessary action with the competent form will be initiated..
7. An Undertaking on Rs.100/- non-judicial paper (in original) will be required stating therein that the firm is neither black listed by any Government / Semi Government Organization nor under litigation in any court of law.
8. In accordance with the rule 33(1) of PPRA – 2004, the competent authority may reject all bids or proposals at any time prior to the acceptance of bids or proposals.
9. Other terms and conditions of Pakistan Engineering Council bidding documents, shall apply mutas mutandis.
10. In case if tenders are not sold/opened due to unavoidable/unforeseen circumstances on 1st schedule date, 2nd schedule will be implemented.
