

- In accordance with PPRA Rule-25; Bid Security as indicated is required in shape of CDR in favor of undersigned from any schedule bank / KCBL bank dully mentioned the name & title of the firm, along with sealed Financial Proposals.
- Rates quoted below 10% of Tender Cost must be associated with the full differential amount as additional performance security in the shape of CDR from any schedule bank / KCBL bank of Pakistan in the name of Executive Engineer LG&RD District Ghizer along with financial bid/NIT otherwise the bid will be treated as defective/non responsive and bid security of such bidder will be forfeited.
