#### **Terms & Conditions**

1. The prices should be firm and final on FCS basis without involving any foreign exchange.
2. **Tender No. 231 and 233 must be accompanied with a Bid Security amounting to Rs. 120,000 and Rs. 2 Million respectively** whereas **Tender No. 232 must be accompanied with a Bid Security @ 2% of total amount of offered material** valid for 120 days in the form of Bank Guarantee / CDR/SDR/ Demand Draft or Pay Order issued by any scheduled Bank of Pakistan (having rating A+ or above) in favor of CEO IESCO.
3. Tender documents / forms including Terms and Conditions / detailed specifications can be obtained from the office of the Chief Engineer (MM) IESCO Head Office, Islamabad against a

non-refundable amount of Rs. 3000/- per tender on any working day during office hours till a day earlier from the date of opening of tender.

4. The bid should be for full tender quantity.
5. Written application on company letter head along with copies of registration with Sales Tax Department/FBR (STRN, NTN registration etc. **printed in year 2024**) should be produced at the time of issuance of tender documents / bid schedule.
6. No tender will be issued on the date of opening of tenders.
7. The bids are valid for ninety (90) days.
8. In case of holiday announced by the Govt. of Pakistan, Strike in IESCO or any other reasons whatsoever due to which this office remains closed on the above schedule tender opening date, the tender will be opened on next working day at same time and place/venue.
9. The blacklisted firm by any Govt. Agency is not eligible for participation in the tender. The firm should submit an affidavit stating that their firm has not been blacklisted by any Govt. / Semi Govt. / Autonomous body and no legal action is underway against their firm.
