a.	NAB intends to get Renewal of Software License for NAB HQ, Islamabad
b.	The tender will be awarded after open competitive bidding as per PPRA rules 36(a) (single stage one envelopes procedure)

### **3. Terms and Conditions**

a.	Reputed firms with valid NTN/GST number should apply.
b.	The firm(s) should be registered with Income Tax and Sales Tax departments.
c.	Black listed firm(s) need not to apply. Interested bidders must submit a certificate/affidavit regarding status of firm pertaining to black listed or not.
d.	The firm(s) should provide a valid vendor number issued from AGPR office Islamabad.
e.	Tender should accompany (refundable) fixed call deposit of Rs.215,000/- in favour of NAB HQ Islamabad, which will be retained during warranty / licenses period.
f.	The approved firms(s) / successful bidder(s) will provide onsite support during license period after issuance of order. If renewal is not made in due time the security amount will be confiscated.
g.	Bidder must be authorized partner / Reseller or provided letter from partner / reseller to participate in the tender.
h.	The bidder are required to provide the company profile alongwith all related documents with the bid. Further, firms must have the experience for providing software/ licenses to at least 2 x Government or Semi-Government organizations during last two years.

i.	The bids will be opened in the presence of bidders or their authorized representative at NAB HQ New building G-5/1, near Radio Pakistan, Islamabad.
j.	The lowest evaluated bids will be awarded the tender.
k.	The procuring agency (NAB) may reject all bids or proposal at any time prior to their acceptance as per Rule 33(1) of PPRA rules 2004
l.	No modification will be allowed once the interested bidders submit their proposal/final bid as per PPRA rules.
m.	An evaluation committee will evaluate the bid headed by Addl. Director.
n.	Bids containing false or misleading statement regarding requirement of request will be rejected.
o.	There shall be no negotiations with the bidder(s) having submitted the lowest evaluated bid or with any other bidder.
p.	The procuring agency shall keep all information regarding the bid evaluation confidential till the time of the announcement of the evaluation report.
q.	The NAB authorities reserve the right to accept or reject any proposal / tender as per PPRA's rules.
r.	Failure to comply with the requirements(s) (TORs) by the bidders may lead the bidders to be non-responsive and may be rejected.
