02. Vehicles can be inspected at NHA Complex Havelian Interchange and office of the Dy. Director (Maint) Unit NHA Abbottabad at NHA Qalandarabad Toll plaza building on any working day upto **10-06-2024** from the date of advertisement. The Public Auction will commence at **11:00 (AM)** on **11-06-2024**. The Auction Notice is also available on NHA website <u>www.nha.gov.pk</u> and Public Procurement Regulatory Authority website <u>www.ppra.org.pk</u>.

03. The participants interested to purchase vehicle (s) shall must have to deposit a refundable/adjustable Pay Order/Demand Draft amounting to **Rs. 50,000/-(Rupees Fifty Thousand only)** in favour of General Manager (NA's) NHA Abbottabad along with copy of valid CNIC, as Expression of Interest/Token money *(Mandatory Requirement),* failing which no person shall be allowed to participate in auction process. The demand draft/pay order must be submitted before **10:00 (AM) Hours 11-06-2024.**

04. Successful/highest bidder(s) shall have to deposit **25%** of the bid amount at the spot (in cash) for each vehicle as earnest money, failing which the bid shall be rejected, token money (*pay order of 50,000/-*) shall be **forfeited** and vehicle will presented again for auction at the end.

05. The successful/highest bidder shall have to deposit the remaining bid amount (75%) within 10 (Ten) working days in shape of Bank Pay Order/Bank Draft in favour of NHA after approval of the bid by competent authority and intimation subsequently, failing which the earnest money shall be forfeited & bid shall be cancelled.

06. Public auction will be held on **11-06-2024** at **11:00 (AM)** at **NHA Complex Havelian Interchange Muslimabad**, **Abbottabad** by the Respective Committee in the presence of eligible bidders. Bidders will provide copy of valid CNIC, complete address, email and telephone/mobile cell numbers.

07. Detail of Registration Documents i.e Book or Return Excise File Available/ Not Available is mentioned in above column and same will be auctioned subject to willingness of bidder to arrange the same at their own end. No claim regarding vehicles, and documents of the Auctioned vehicles rather than mentioned in above columns will be entertained, after Auction.

08. Remaining/Outstanding Token Tax etc will be paid by the successful bidder.

09. Government Tax (s) (whatsoever admissible) will be charged as per prevailing Federal Government/FBR Rules, besides Bid Price separately.

10. The vehicles shall be handed over to successful/highest bidder after full payment, depositing of Taxes in FBR/Designated Bank and after transfer of ownership from the concerned ETO/Motor Registration Authority at his own expense/arrangement.

11. NHA Reserve the right to accept or reject any or all bids and to add or withdraw any vehicle before Public auction as per rules.

12. In case of any dispute the decision of Auction Committee shall be final and not challengeable in any court of Law.

13. Queries (if any) can be cleared at the spot thereafter no objection shall be entertained and decision of Auction Committee shall be final.
