TENDER NOTICE

The Directorate of Tourism & Culture GB invited bids/services of potential firms/companies for hiring of services i.e construction of GB Float, for Pakistan Day JS Parade, 2024 and supply of traditional dresses, food, accommodation & transport during the event. Sealed quotations from reputable firms having ample experience are invited as per terms/conditions and guideline mentioned below;

TERM AND CONDITIONS

1. Tender documents must be in two separate envelopes (**i. Technical Proposal & ii. Financial Proposal**) clearly mentioning on the envelopes; otherwise the offer/envelope shall be rejected unopened at the spot.
2. Quotation should be accompanied with 5% of total cost as security deposit in shape of call deposit/bank draft in favor of Director Tourism Gilgit-Baltistan in the envelop of **Financial Proposal**, failing which the tender will be liable to rejection.
3. Offered rate must be clearly mentioned on the Tender Documents issued by the Department. Rates offered out of the attached Departmental format shall not be considered.
4. Offered rates should be included all kind of taxes being collected in GB.
5. No additional transportation charges shall be claimed for loading and unloading of goods/ products.
6. Payments will be made as per Govt. procedures through AGPR.
7. No advance payment shall be admissible.
8. Warranty for electronic items should be for one year or mentioned (time period) clearly.
9. All the quotation will be evaluated on lot basis.
10. **Blank or missing** of any item rate may be treated as cancellation of the applied LOT.
11. Contractor/firm can apply for one or more lots.
12. Preference will be given for those who have relevant experience in relevant field (Certificate must be attached).
13. All the activities, contract will be made on event and situation basis as per demands and approvals.
14. The firm should be in operation for a minimum of 3 years in designing creative work for print and publicity material.
15. No TA/DA charges shall be paid to bidders for participation in bidding process.
16. The Firm, Company, Bidder must have qualified professional team of repair of the vehicle and workshop at Gilgit.
17. The Department reserves the rights to accept or reject any/ all as per PFRA Rules 33(1).
