### MEPCO TENDER NOTICE

#### FOR ENTERING INTO CELLULAR TELECOMMUNICATION SERVICE CONTRACT

Sealed tenders (as per Single stage one envelope procedure) are invited from Telecommunication Services Providers duly authorized by the Govt. of Pakistan and Pakistan Telecommunication Authority (PTA) to provide cellular telecommunication services to MEPCO through a contract agreement.

#### GENERAL TERMS & CONDITIONS

- The duration of the contract will be initially for 02-Years extendable (with mutual consent) on good performance of service provider.
- The bidder must be authorized by Govt. of Pakistan and Pakistan Telecommunication Authority (PTA) to provide cellular communication services and shall provide the copy.
- The bidder must submit the GST and Income Tax Registration Certificate along with the bid documents.
- The bidder shall submit district-wise service area falling under MEPCO jurisdiction / big cities of Pakistan with service period.
- The bidder shall submit copies of such contract agreement signed with Govt. / Semi Govt. / private institutions with satisfactory service certificate issued from concerned Authority.
- The detail of monthly financial ceilings and grades of the officers / officials (using this facility) are given below for working / analysis of the service provider for offering on net, off net and internet packages etc.: -

- Tender duly sealed and super-scribed as “**Tender for Cellular Communication Services to MEPCO**” must be delivered in the office of Director (Admn) MEPCO HQs Khanewal Road Multan on **07.03.2024**, upto 10:30 AM (by hand), which will be opened at 11:00 AM on the same date and in the presence of the representatives of the companies, who may like to attend. In case of late submission, Tenders will not be entertained.
- Each tender must be accompanied by bid guarantee of Rs.1200,000/- in the form of Bank Draft or CDR payable at Multan in the name of **Finance Director, MEPCO HQ Khanewal Road Multan** otherwise tender will not be entertained.
- The successful bidder shall submit performance guarantee issued by any Scheduled Bank of Pakistan equal to one monthly bill, which will be valid for entire period of contract and will be forfeited in case of unsatisfactory services assessed through a committee constituted for the said purpose and ban will be imposed upon the service provider for its participation in future MEPCO Tendering for providing cellular services.
- The Bids should remain valid for 120 days and bid guarantee should remain valid till 150 days from the bid opening date.
- MEPCO reserves the right to reject all bids as per clause 33 (1) of PPRA Rules 2004.
