6. Undertaking on stamp paper that firm is neither involved in any litigation or abandoned any work in any department, nor blacklisted as a result and certificate to the effect that all documents particulars/ information furnished are true and correct.
7. No conditional bid will be entertained.
8. In case of joint venture, a legal agreement between the parties would be required.
9. International firms having joint venture with local firms are also eligible to apply.
10. Summary of the overall experience indicating separately the details of similar assignment duly completed and in progress.
11. Information about the projects implemented, with cost of each project, amount of consultancy contract, number of full-time staff working on the project, number and expertise of consultants/resources person employed and duration of the project.
12. Incomplete applications will not be entertained.
13. Detailed Terms of Reference (TORs), evaluation criteria and other documents/ information can be received from the office of NIBGE, Faisalabad depositing requisite fee of **Rs. 500/-** on or before **08-10-2020** during office hours.
