Tenders will be issued to the scrutinized contractors. The tenders must be received in the office of acceptance officer by the **10 Nov 2023 till 1130 hrs** and will be opened at **1200 hrs** on the same date.

Note: -Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All Contractors will certify in writing that hey are registered with Pakistan Engineering Council (PEC) and will submit a copy their registration. Contractor with PEC are ineligible to apply.

4. Contractor born on approved list of MES in category 'B', 'C' and 'D' and above and also having experience of this type should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officers reserve the right to accept or reject the tender. Rejected tenders will be dealt with as per para 33 (i) of PPRA Rules.
