TERMS & CONDITIONS

1. Price of the bidding documents is Rs.2500/-(non-refundable).
2. 2% (two percent) earnest money / bid security of quoted cost must be accompanied in the shape of Call deposit in the name **Cantonment Board Malir**, issued from Scheduled banks in accordance with the Rule 25 of PPRA Rules, 2004 (as amended up to date). An Affidavit to the effect stating that 2% bid security / earnest money has been placed in financial proposals / bids must be attached in the technical proposals.
3. The Submission of bids by the contractors implies that they are fully conversant with the scope of work, terms and conditions laid down in the tender / bid documents.
4. Both Technical and financial proposals / bids will be placed in single sealed envelope dully addressed and sent to office of Cantonment Board Malir, Aziz Bhatti Road, Bostan line Malir Cantt, within due date & time of closing of tender box. The Bids shall be received on 5.12.2022 @ 12:30pm and only technical proposal will be opened @ 1:00pm on the same day in the presence of contractors or their authorized reps who happened to be present at that time.

5. Firms/Suppliers black listed by any Government Department found to be indulged in corrupt or fraudulent practices will be considered non responsive by Cantonment Board Malir..
6. If any document submitted along with bid documents found false / bogus, the registration of the contractor / firm shall stand cancelled / blacklisted in the light of enabling provisions of PPRA Rules 2004. Conditional / Incomplete bids shall not be accepted.
7. The **Financial Bids / Proposals** of only technically responsive qualified bidders will be opened after evaluation of **Technical Bids** in the presence of bidders / their representatives (who may like to attend) in the office of the Cantonment Board Malir on the date and time to be notified later on whereas the **Financial Bids** of technically non responsive bidders shall be returned unopened to the respective contractors.
8. All the government taxes (Federal, Provincial & any other) will be deducted as per prevailing government policy.
9. Incomplete / disfiguring / overwriting by hand / delayed bids shall be declare non responsive.
10. Successful bidder shall be bound to execute an agreement with Cantonment Board Malir and all terms and conditions included in tender notice shall be the part & parcel of the agreement.
11. The validity of Tender rates shall be minimum up to 90 days.
12. As per PPRA Rule 33, the Cantonment Board Malir may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The Cantonment Board Malir shall upon request communicate at any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
