- 2. Official bids will start from the reserve price; bids below this will not be accepted.
- 3. A security deposit (Pay Order/Demand Draft) must be submitted in favor of Chairman NAB on or before auction date and time at NAB Rawalpindi Office, Sector G-6, Civic Centre, Islamabad.
- 4. The security deposit to unsuccessful bidders would be returned on the same day.
- 5. Bidding documents are available at www.nab.gov.pk or can be collected from the NAB office Sector G-6, Civic Centre, Islamabad.
- 6. Company representatives must provide a **power of attorney**, duly stamped and signed by the CEO (for companies).
- 7. The bid will be finalized in the name of the **highest bidder**.

- 8. The successful bidder must pay 25% of the bid amount via Pay Order/DD within 7 days of bid acceptance, failing which the security deposit will be forfeited.
- 9. The remaining **75% of the bid amount** must be deposited via Pay Order/DD within **one month**, otherwise, the amount submitted would be forfeited and the property/vehicle will be re-auctioned.
- 10. Taxes, Transfer Fees, and all other government-related expenses will be borne by the successful bidder.
- 11. The successful bidder is responsible for all post-purchase legal/administrative formalities.
- 12. The Competent Authority/Auction Committee reserves the right to accept or reject any bid without prior notice. The auction will be conducted as per PPRA Rules & prevailing laws.
