1. Sealed tenders/ quotations are invited for Ammunition Depot Okara and list of miscellaneous items are available from Depot during working hours. Terms and conditions are highlighted below.
2. **RATE**
  - a. Quoted rates must be valid upto **30 Jun 2025**.
  - b. Quoted rates must be inclusive of all the Govt taxes i.e. **GST , Income and other Govt Taxes.**
  - c. Rate will be quoted for brand new items.
3. **QUOTATION** Quotations will be received in depot by hand/ courier on due date.
4. **RESTRICTION**
  - a. Cutting or overwriting in the quotation makes it liable to rejection, same may be avoided.
  - b. The purchaser retains the authority to reject any or all the quotations as per PPRA rules.
5. **SUPPLY REQUIREMENTS**
  - a. The store (s)/ items must be in accordance with the specifications/ samples provided by this depot.
  - b. Samples will be required from the firms to assess the quality and functionality of the item.
