Sealed bids (as prescribed in Bid Data Sheet of the Bidding Document) of the submitted e-PADS Tender Prints in accordance with the provisions of Rule 36 (a) of Public Procurement Rules, 2004, read with e-PADS Regulation and terms and condition defined in the bidding document supported by Bid Security **Rs. 20 Million** in the shape of pay order / demand draft / call deposit / banker's cheque in the favour of "FEB&GIF" reach the PD Office, Islamabad on / or before **1100 hours by 7<sup>th</sup> May, 2025**. E-bids will be opened on the same date at **1130 hours** in the presence of the bidders or their authorized representatives, who may choose to be present.
