



RE-INVITATION FOR BIDS (RIFB)

**MAINTENANCE OF LAHORE EASTERN BYPASS &
PATROLLING FOR PROTECTION OF FENCE
(PUNJAB-NORTH REGION)**

1. National Highway Authority (NHA) invites sealed bids from eligible bidders who can prove their eligibility and qualification as mentioned in the Bidding Documents for the captioned subject. The estimated cost and other briefs of project are mentioned below:-

2. Bidding will be carried out by adopting “**Single Stage Two Envelopes**” procedure. Bidders are required to be registered with Pakistan Engineering Council with a valid registration Certificate in **Category C-5** or above for the year **2022** having specialized Code **CE-01 & CE-10**.

3. Bidders can download bidding documents from NHA website. **The bidders are advised to visit the site before submission of bids.** Bids shall be received in NHA Regional Office Conference Room, Lahore on **6th December, 2021** until **1100 hours**. Bidders’ representatives would be required to present the “Authority to submit the Bid” while submitting the bids. The envelope containing ‘Technical Bid’ will be opened on the same day at **1130 hours** in the presence of bidders / their authorized representatives who choose to attend. Second envelope containing “Financial Bid” of technically qualified bidder(s) will be opened later, the date of which will be communicated after evaluation of the Technical Bids.

4. Bid security of an amount (2% of Engineer’s Estimate) in favour of “**NHA RMF Security Deposit / Retention Money Account**”, in the form and validity as mentioned in the bidding documents, must be accompanied with “**Technical Bid**”.

5. Bidders representatives would be required to present the “Authority to Submit the Bid” while submitting the bids, if failed to provide Authority Letter, their bids will not be considered. The Bidders will provide the **No Litigation Certificate** on judicial stamp paper or information about any litigation along with Technical Bids. **Audit Reports** of Last three (03) years by chartered accountant firm must to be provided with technical bids as per standard format. Required **machinery** and **technical staff** must be provided on judicial stamp papers along technical bids indicating the contract title. Bidder will provide details of ongoing works alongwith performance certificate from concerned office In-charge

6. The firms providing unsubstantiated and / or incorrect information are liable to disqualification and /or legal action. NHA reserves the right to reject all bids as per the PPRA Rule No. 33(1).
