ELIGIBILITY

2. This Invitation for Bids is open to all Bidders who meet out the following requirements/criteria.
 - a. PEC certificate renewed for the Year 2024-25.
 - b. Identity Card of Contractor/Managing Partner/Director of the firm or his authorized person.
 - c. Bidding documents will be issued only to the Owner or his authorized person having authority letter on Rs.100/- judicial stamp paper for receiving tender documents/participants in tenders.
 - d. All bid must accompanied with 3% of total bid price as bid security for each tender in the shape of CDR from any scheduled bank from their own Bank Account & must entered the name of firm on CDR in favour of Project Director GSC SEPCO Sukkur.
 - e. The difference of Call Deposit must be submitted alongwith tender documents at the time of submission of Bids, calculated on total offered Bid.
 - f. The tenders will be received back on scheduled date & time mentioned against each and will be opened on same date & time. If undersigned or any other committee member of tender opening committee will be out of Headquarter or any announced public holiday, the same tenders will be opened on the next working day.
 - g. The successful lowest bidder shall provide the 10% of the contract price as performance security.
