- Only Bid through E-Pak acquisition and Disposal System (EPADS) will be entertained (www.eprocure.gov.pk). No bid other EPADS will be accepted.

- Tender form can be obtained from EPAD from the publication of this advertisement on submission of written request on letter head pad of Firm with copies of CNIC, NTN and GST Number of Proprietor.
- The Bidders should deposit 2% Earnest Money of the quoted amount in the shape of Bank Draft from any Scheduled Bank in favor of Divisional Accounts Officer, Pakistan Railways, Sukkur Division and attach it with Tender Form Earnest Money Should be worked out on the Price including of all taxes.
- The overall approximate cost of the tender items comes to Rs.4.270 million.

- The Tender will be opened in the presence of Tender Committee members on the same date at 11:30 hours.
- Bidding will be conducted using National competitive bidding procedures as specified in the Public Procurement Regulatory Authority (PPRA-2004-08).
- The Bidder who is on **Active Taxpayer's List (ATL) of FBR** will be eligible to participate in the tender.
- Conditional, incomplete tender without 2% Earnest Money and Bidder(s) not fulfilling the above mentioned requirements shall be considered as non-responsive and shall stands disqualified i.e. Bidder(s).
- The rules quoted should be valid for a period of 90 days after the bid opening date. The successful bidder shall give performance guarantee @ 05% of the contract amount.
- The Bidders shall provide the samples of each item at the time of opening tender; otherwise offer will be rejected by the Tender Committee. Specification of items will be given to the firm at the time of purchasing of tender form.
