Invitation to Bid (Tender Notice # PPC-01/2025)

Installation of Solar Power System at student's hostel (Block A & B)

1. Women University Mardan invites sealed bids from reputed Firms having adequate experience in carrying out projects of similar nature, valid registration with PEC in minimum Category C-6 with relevant field of specialization (EE11), valid Income Tax & Sales Tax registration and who are on Active Tax Payers' List at the time of Submission of Bids for the above-mentioned project.
2. Bidding documents can be obtained from 21/04/2025, to 06/05/2025 during working hours from the office of Project Director, Main Ring Road (North), Near Shankar, Women University Mardan upon payment of non-refundable fee of Rs. **3000/-** (Pak Rupees three thousand's only) as Pay order/ Bank draft in favor of Women University Mardan.
3. Single Stage – Two Envelope (1S2E) Bidding Procedure as per PPRA rule 36 (b) will be adopted, an envelope comprising technical information of Bid shall be clearly marked as “Technical Proposal” and the other envelope containing the Bid Price shall be clearly marked as “Financial Proposal.”
4. Pre-bid meeting will be held on **28/04/2025** at **11:30 A.M** in the Committee Room, New Library building, of Women University Mardan.
5. The envelop marked as “Financial Proposal” shall be accompanied by Bid Security in the amount of minimum of 2% of Quoted bid price and in the form of Deposit at Call or Bank Guarantee issued by a scheduled bank in Pakistan in favour of Women University Mardan.
6. The Bidder shall provide an undertaking along with Technical Bid stating that requisite Bid Security is sealed within the envelope of Financial Proposal.
7. Envelopes of “Technical Proposal” and “Financial Proposal” shall be submitted at the address mentioned below by **07/05/2025 upto 11:00 AM**. The envelope containing Technical Bid shall be opened on the same day at **11:30 AM** in the presence of Bidder's representatives who choose to be present. Bids received after the prescribed time and date shall be rejected.
8. Bidders will be Technically Qualified on the basis of information provided with the Bids, as per the Criteria prescribed in the Bidding Documents.
9. Envelopes of Price Bids of only “Technically Qualifying/responsive Bidders” will be opened in the presence of Bidder's representatives who choose to attend the meeting at the date and time to be determined and communicated later on. The bidder's representatives shall have authority letter, duly signed by the owner.
10. Envelopes of “Price Bid” of Bidders who fail to qualify shall be returned to them unopened.
11. The Authority of WUM reserves the right to accept or reject any or all Bids or proposals at any time prior to acceptance of any bid as per rules.
