Contractor not born on MES approved list of contractors or THOSE SUSPENDED from the approved list of MES contractors due to non-depositing enhanced amount of standing will deposite earnest money equal to 2% of the estimated cost of bid in the form of DSC, SDR ets duly pledged in the name of GE (A) Svcs Multan Cantt. This amount is refundable, if the contractor's pre-qualified or they do not secure the contract.
