


**TENDERNOTICE**

Original bid security in form of Bank Guarantee/CDR/Pay order in favor of Divisional Accounts Officer, Pakistan Railways, Sukkur, shall be submitted before opening of tender physically in the office of Divisional Assistant Electrical Engineer, Pakistan Railways, Sukkur. Original of the bid security shall be attached with the technical bid. Bidder will also upload the complete scanned copy of their bid in EPADS on or before **05.05.2025 at 11:00A.M.** Date and time mentioned in tender documents will be applicable. 01 hard copy of technical bid should be submitted in office Divisional Assistant Electrical Engineer, Pakistan Railways, Sukkur, however, technical bid/ documents uploaded on EPADS will be considered for technical evaluation.

- Bids without original bid security will not been entertained.
- The bid prepared in accordance with the instructions contained in the bidding documents must be submitted on EPADS as per the schedule mentioned in the table above.
