2. The invitation of bid is open to firms meeting following criteria:
 - I. Having valid registration with Pakistan Engineering Council (PEC) in category C-6 or above and having specialization in CE-10 & EE-04.
 - II. Active taxpayer as per FBR’s database i.e. active taxpayer (ATL).
 - III. Affidavit on stamp paper (that the firm has not been blacklisted by private, Govt., Semi Govt. and Autonomous Body)
3. The bidding action shall be undertaken on the basis of PPRA Rule 36(a) “**Single Stage-Single Envelope (SS-SE)**” open bidding procedure. The firms capable of carrying out this work are advised to furnish complete information in accordance with the requirements of bidding documents.

The duly signed and stamped original priced bid shall be uploaded on **EPADS** and also submitted in sealed envelope accompanied by non-refundable tendering fee of **PKR Rs. 10,000/-** (Pak Rupees Ten Thousand Only) in the shape of CDR in favor of Treasurer, National Skills University Islamabad (FTN 9011011-7) at the address given below.
5. Furthermore, all bids must be accompanied by a Bid Security / earnest money @ two percent (2%) of Bid Value in the shape of CDR in favor of the Treasurer, NSU Islamabad.
