E-Tenders without submission of Bid Security in favour of FGEHA will be rejected. If any difference / discrepancy / deviation between submissions of online bid and hard form is found, the bidder shall be declared non-responsive.
- Technical Proposals shall be opened on the same date at **12:30 Hrs in the Committee Room, First Floor, FGEHA Head Office, 10-Mauve Area, Sector G-10/4, Islamabad**, in the presence of bidder(s) or their authorized representative(s). Bidders will be **technically qualified** on the basis of information provided within the proposals in the light of Bidding Documents. Firms who fail to qualify technically shall not be considered further.
- All the applicable Federal/Provincial taxes (income tax, sales tax, etc.) must be included while preparing the Financial Proposal and are required to be built in the quoted rates and not to be mentioned separately.
- Partial, incomplete and conditional bids will not be entertained.
- The bidders providing fake, forged, unsubstantiated and false information shall be liable to legal actions i.e. disqualification and blacklisting.
