2. The contractors are required to submit their applications to ACE 30 Corps Gujranwala Cantt for issuance of tender documents alongwith their complete credentials as shown at (Serial # 8). The applications shall be scrutinized and the tender documents will only be issued to the firm who have sufficient experience in relevant field and satisfy other special conditions required for the job and area. Tender will only be issued to the prequalified contractors. 3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration certificate. Contractors not registered with PEC are ineligible to apply.

4. Contractors borne on approved list of MES in Category A, B & C and also having experience of this type should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserve the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.


