

The contractors will be able to see comparative statement online.
2. The bidder shall submit 5% bid security (PPRA) of Sanitation estimate cost sealed in envelop in the shape of call deposit at (original) only through courier before closing as above date and time.

The bidders can register themselves with Karachi Cantonment Board at etender.mlc.gov.pk for online bidding one day prior to the last date of submission of the electronic bids.

4. Who provides incorrect information shall stand disqualified and will be debarred under rule 19 of the PPRA Rules (As amended).
5. Successful bidder shall sign the agreement with the procuring entity within Ten (10) days after acceptance of bid.
6. The quoted rates shall be inclusive of all applicable Government (Federal/Provincial) Taxes.
