- 4. Tender form shall be issued to the Contractors in person on production of original CNIC and Bid security (03%) as mentioned above against each work.
- 5. Conditional, incomplete, lump sum and bid filled with led pencil will not be accepted.
- The procuring agency may reject all bids or any one at any time prior to the acceptance of proposals or bid under the provision of PPRA rules.
- Rates quoted below 10% of T/S amount, the bidder shall have to deposit an additional 50% of differential amount (between TS & bid amount) as performance guarantee along the bidding document otherwise bid shall be rejected.
