Khyber Pakhtunkhwa, Police Department invite sealed tenders based on the Khyber Pakhtunkhwa for Public Procurement of Goods, Works & Service Rules 2014 from eligible bidders/firms having previous experience as well as registered with income Tax and Sales Tax Departments, for Financial Year 2022-23. Tenders should be addressed to the Add: IGP/Headquarters, Government of the Khyber Pakhtunkhwa Police Department, Peshawar. Last date for submission of proposal is 21.03.2023 upto 1100 Hrs.: Technical proposals will be opened on the same date at 11:00 Hrs: in the presence of Tender Evaluation Departmental Purchase Committee and intending bidders in Conference Room CPO, Khyber Pakhtunkhwa Peshawar. The delivery period will be 90-days or as per contract agreement.

3. **TERMS & CONDITIONS:**

The following terms and conditions shall apply:-

- i. The offers shall be accepted only with original bidding documents. Photocopies will not be accepted.
- ii. Only registered suppliers, who are on Active Taxpayers list (ATL) of FBR, are eligible to supply goods/services to Government departments.
- iii. All firms are required to be registered with Khyber Pakhtunkhwa Revenue Authority.
- iv. Each firm shall submit a sample on the date of opening of technical proposals except at S/No. 1 & 02.
- v. Each bid shall comprise a single sealed package containing two separate envelopes as under:-

Technical Proposal (Details of specifications, make, country etc. on the firm's letter head pad alongwith catalogue & bidding documents for respective item and submission of an affidavit on Judicial Stamp Paper that 2% Earnest money/bid security is attached with Financial Proposal).

Financial Proposal (Rate of respective item including all taxes/charges whatsoever as per following form on the firm's letter head pad along with 02 % earnest money).

- v. Envelops should be marked in bold letters as **“TECHNICAL PROPOSAL”** and **“FINANCIAL PROPOSAL”**: respectively with name of item.
- vi. Technical proposals will be opened on 21.03.2023 at **11:00 hrs**: while Financial Proposals shall remain (in sealed form) in the custody of the Police Department and would be opened in the presence of bidders after receipt of the technical report.
- vii. The bidders shall submit bid security from the account of the firm/bidder/contractor of any scheduled bank with their financial proposals in favour of the Inspector General of Police, Government of the Khyber Pakhtunkhwa, Police Department Peshawar. In case of non-acceptance of tenders, the earnest money will be refunded after finalization of the tender.
- viii. In case of acceptance of tenders, the bidders shall deposit a security @ 10% of the total value of stores in the form of Call Deposit in the name of the Inspector General of Police, Govt: of the Khyber Pakhtunkhwa, Police Department Peshawar and sign the contract agreement with Police Department within 15-days of the issuance of the acceptance letter.
- xi. The Items shall be received in the MT Store Tele Communication & Transport and Centralized Store at Malik Muhammad Saad Shaheed Police Lines, Peshawar. No other destination shall be acceptable. Items shall be physically inspected by Inspection Committee constituted by competent authority and thereafter operationally tested at the cost of contractor in Peshawar only. Items not found according to the standard specifications, will be rejected at the cost of contractor and may also result in forfeiture of security and black listing of the firm.
- xii. Rates quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges and inclusive of packing/freight till delivery to the Centralized Godown/MT Store Tele Communication & Transport at Malik Muhammad Saad Shaheed Police Lines, Peshawar. Rates shall be valid up to **30.06.2023**.
- xiii. Conditional tender/application will not be entertained.
- xiv. All taxes will be deducted as per existing government policy.
- xv. The procuring entity will have the right to reject all bids or proposals at any time prior to the acceptance of bidders proposal. The procuring entity shall upon request communicate the grounds for rejection of bid or proposal to any contractor or consultant who submitted a bid or proposal.
