



Re-INVITATION FOR e-BIDS

(TENDER NO.MWS/22-23-01)

1. National Highway Authority (NHA) **invites e-Bids** for **SUPPLY OF PORTABLE/MOBILE SLOW SPEED WEIGH IN MOTION (SSWIM) EQUIPMENT** from eligible Operators/ Contractors having valid minimum O-4/C-4 PEC registration certificate and also registered with Income Tax department and who are on active Taxpayer List of Federal Board of Revenue. Method of selection will be based on “Combined Evaluation” Criterion as per Clause-**ITB-29.2** and “Most Advantageous Bid” in accordance with provision of Rule 2(1)(h) of PPR-2004 as amended.
2. The bidding shall be done through NHA e-Bidding System. All Prospective Bidders are required to create their “On-line User Account” for participation in the bidding process. User Guide and video tutorial, illustrating the steps to create “On-line User Account”, are available on homepage of NHA e-Bidding System website (www.ebidding.nha.gov.pk). Access to “NHA e-Bidding System” for bidding, will be granted upon submission of pre-requisite documents as per guide line. e-Bid (e-Proposal) submitted, by using NHA e-bidding system, will only be considered, whereas other bids (proposals) will be rejected. User Guide and video tutorial for Preparation & Submission of e-Bids (e-Proposal) are also available on homepage of NHA e-Bidding System website
3. Complete set of Bidding documents for the above mentioned works, containing detailed terms & conditions, method of procurement (Single Stage - Two Envelopes procedure), submission of e-Bids, Bid validity, opening of e-Bids, Evaluation Criteria, etc. will be available free of cost on NHA e-Bidding website from **6th March, 2023** for downloading. All Prospective Bidders are also advised to follow the NHA website for updates of bidding schedule and addendum(s), if any.
4. The e-Bid must be prepared and submitted through NHA e-Bidding system in accordance with the instructions contained in the Bidding Documents. Hard copy of e-Bid prepared through NHA e-Bidding system, must reach at the address mentioned below on or before **28th March, 2023 till 1100 Hours**. Technical e-Bids (submitted through NHA e-Bidding system) and envelope containing hard copy of Technical e-Bid, will be opened on the same day at **1130 Hours**.
5. The bidders providing unsubstantiated and/or incorrect information shall be liable to disqualification and/or legal action.
