- 2. The Security Companies/firms must be registered with Employee Old Age Benefit institution (EOBI) for EOBI deductions/payments under EOBI act.
- 3. The firm should have a minimum of five (05) years' experience of similar assignment and should have a proper setup/office at Islamabad/Rawalpindi.
- 4. The Purchase Committee of AGPR shall open the Pre-qualification proposals at 11:30 A.M on 20th May 2025 .in the presence of the bidders or their authorized representatives, who may like to be present. The technical proposals shall be evaluated as per criteria given above. Bids not complying with the requirements above shall be declared as non-Responsive and their financial proposals shall not be opened.
- 5. The Purchase Committee shall open the financial proposals (**Annex-I**) of technically prequalified firms. Date and time for the opening of financial proposals to be communicated electronically through EPADS.

- 6. Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 7. The contract shall be awarded to the lowest evaluated bidder.
- 8. If two or more bidders quote the same prices in financial proposal, then the contract will be awarded to the most advantageous firm as per criteria.
- 9. The security company will be responsible to get each guard medically examined by a Registered Medical Practitioner. Similarly, the Company shall provide Character Certificate (endorsed by local police station) of each guard.
- 10. The guard provided by the Security company should not be less than 25 years and not more than 50 years of age. Bulky/overweight person not be accepted.
- 11. The Security company shall provide uniforms and all necessary equipment's (at least 2x Hand held Metal Detectors and 1x Vehicle search mirror) to the security guards to the entire satisfaction of the AGPR.
- 12. The Security Company shall provide to the AGPR, trained security guards ex-services personnel who shall be able to perform security services in accordance with best industrial practice and to the entire satisfaction of the AGPR
- 13. The bid validity period shall be (03) months, starting from the last date of receipt of bids.
- 14. The earnest money of Rs. **300,000/-** (Rupees: Three Hundred Thousand Only) of the un-successful bidders shall be released after award of tender letter.
- 15. The successful bidder shall be required to enter into a formal Contract Agreement, to be executed with mutual consent of both the parties.
- 16. The proposals should not have any over-writing or cutting. The Bid opening committee of AGPR reserves the right not to consider the proposal having aforementioned deficiencies.
- 17. Payment of the bills shall be subject to the deduction of mandatory government taxes/levies.

- 18. During the currency of the contract, the firm shall provide Security Services as per terms and conditions, to be settled later on in the shape of contract agreement, failing which the earnest money shall be forfeited by the AGPR.
- 19. In case, the **additional Security Guards** are required by AGPR form successful bidder the security company shall provide the services on the same rates, terms and conditions.
- 20. All terms & conditions laid down herein shall be part and parcel of the Contract Agreement of Security Services is attached at **Annex-II** In case of failure to adhere with terms & Conditions laid down in Contract Agreement, AGPR, reserves the right to terminate the agreement with or without giving notice and forfeit Performance Guarantee and any amount due toward Security Company.
- 21. Interested firms may visit the office of AGPR at any time during working hours.
- 22. Before submission of bid, the terms & conditions of the tender documents must be read carefully. After submission of bids and till finalization of tendering process and award of contract, no query will be entertained.
