Bidder Must claim their deposit refund (Bid Security/performance Gurantee) within 180 days of the financial bid opening (if rates are higher side) or completion of contract period/project (in case awarded) or in case of any earlier termination. The time barred CRs (receipts)/refund cases shall not be processed. All bids must be accompanied by a Bid Security in the shape of CDR/PAY order/DD @5% (five percent)
