3. The Bidding shall be held as **a single stage** two envelopes procedure as per PPRA rules No. 36 (b). Single Package containing two envelopes one for Technical and other for **financial** proposals. Rates quoted must include all taxes in Pak Rupees.
4. Financial documents of the technically qualified firm(s) will also be opened on the same day/date or any other working day with prior information to technically qualified firms.
5. Financial bids must be accompanied by an earnest money @ **3%** of bid cost in the shape of **Call Deposit** from a scheduled Bank of Pakistan in favor of **Director P&D LUAWMS-Uthal** and tender found without 3% Earnest money will be rejected forthwith.
6. The bidder who withdraws (at tender opening occasion) or modifies his tender after submission, his earnest money will be forfeited. No conditional tender will be entertained under any circumstances.
