





Terms & Conditions

- 1) Tender form showing details/specifications of the requisite "Uniform Articles" can be obtained from General Branch of this Collectorate on any working day before closing of office hours. The bids are to be submitted to the undersigned in sealed / confidential cover at the address mentioned below and the same will be opened on the same day by the Purchase Committee in the presence of bidders or their authorized representatives.
- 2) The quoted rates must be inclusive of all applicable duties / taxes.
- 3) Earnest money / bid security @ 5% of the total bid price (refundable) in shape of pay order in favor of the Collector, Collectorate of Customs Appraisalment (West), Lahore should be enclosed with the bid. Any bid which is not accompanied by the earnest money / bid security at the time of opening of bid shall be rejected.
- 4) The quantity of items to be purchased can be increased or decreased.
- 5) The validity period of the bid / rates will be applicable up to 30.06.2024 from the date of opening thereof.
- 6) All items will have to be supplied strictly as per specifications mentioned in the tender form within 10 days of the issuance of purchase order.
- 7) Attested copies of Sales Tax Registration and NTN must be attached with the bid.
- 8) Samples of the material major items must be accompanied with the bid for evaluation and comparison with the other bidders by the Purchase Committee.
- 9) Procuring agency may reject all bids or proposals at any time prior to the acceptance of bid or proposal. The procuring agency shall communicate the bidder for its rejection, but is not required to justify grounds for rejection.
- 10) Payment will be made after receipt of all the items mentioned in the supply order.
- 11) No bid shall be entertained after given cut of date and time.
