IESCO Intends to invite Bidding from eligible and reputable cellular Service Providers having valid license from Pakistan Telecommunication Authority (PTA) for **“Procurement of M2M 4G/2G SIM Cards and Connectivity for Advanced Metering Infrastructure Project”** as per following lots. The details of Package No. 01 & 02 are given in Tender Documents. As per IESCO requirement, two different Cellular Service Providers are to be hired through following two (02) No. of lots to cover the Rawalpindi Circles, Taxila Division and entire jurisdiction.

5. Bid shall be accompanied with Bid Security amounting to Rs. **250,000 PKR/-** (Two Hundred Fifty Thousand Rupees) in favor of the Chief Engineer (Development), IESCO valid for 28 days beyond bid validity. The bid shall be valid for **60 days**.
6. The firm(s) will be selected in accordance with the procedure set out in the Tender Document. Interested bidders can obtain Tender Documents from Office of the undersigned at a price of Rs. 5000/- each (nonrefundable).
7. The original bid along with Two copies, properly filled in, and enclosed in a sealed envelope(s) must be submitted to the undersigned on or before **02nd June 2025 at 1100 Hrs.** Bid shall be opened on the same day at 1130 Hrs. at the office of Chief Engineer (Development) IESCO.
