5. Undertaking on Rs. 100 legal valid and attested stamp paper that the firm is not blacklisted by any of the provincial or Federal Govt. Department or Autonomous body or private sector organizations anywhere in Pakistan.
6. Submission of CNICS of the owner(s) for AML (Anti- money Laundering) and CFT (Counter Financing of Terrorism) Clearance.

Applicant failing to fulfill above conditions shall be disqualified. Technical Evaluation Sheet should be obtained from undersigned office.

The pre-qualified firms shall be entitled to participate in the further proceedings. All participating firms will be communicated in writing whether they are pre-qualified or not.
