#### 1. Introduction

Central Cotton Research Institute (CCRI), Multan is a premier institution since it was established in 1970, at the national level under the aegis of Pakistan Central Cotton Committee (PCCC), Ministry of National Food Security and Research (MNFSR), Government of Pakistan. The institute has played a pivotal role in advancing and generating knowledge in the field of cotton research and development.

CCRI, Multan is committed to contributing significantly to the enhancement of the cotton industry in Pakistan. Its mission revolves around continuous research, innovation and the development of sustainable practices in cotton cultivation. Throughout its distinguished history, CCRI, Multan has achieved numerous milestones in the realm of cotton research. The institute has been at the forefront of developing high-yielding cotton varieties with standardized fiber quality characteristics.

#### 2. Objective

The primary objective of this <u>electronic bids through e-PADS</u>, **PPRA** is to procure a reliable and qualified Firm/Supplier for the timely and efficient supply of weedicides, fertilizers and insecticides for cotton crop cultivation, 2025.

#### 3. <u>Procedure of the Open Competitive e-Bidding</u>

Single Stage Two Envelop Bidding of <u>Electronic e-PADS Procedure</u> shall be followed. The said procedure is reproduced as follows:

Note: Manual submission of bid without e-PADS is NOT ALLOEWD

- i. The procuring agency will first evaluate electronically the **Technical Proposal** based on predefined criteria, without considering the price. Only proposals that meet the required specifications and standards will proceed to the next stage.
- **ii.** After evaluating and approving the **Technical Proposals**, the procuring agency will upload the evaluation report on e-PADS as per the scheduled timeline.
- **iii. Financial Proposals** will be opened electronically as per the scheduled time. The technical evaluation report will be uploaded on e-PADS as planned.
- iv. If a disqualified or non-responsive bidder submits a written statement confirming they are satisfied with the procurement process, the procuring agency may return their unopened financial proposal earlier.
- **v.** The evaluation report of the Financial Proposal will be uploaded on e-PADS as per the scheduled timeline amd the contract shall be awarded to the lowest evaluating bidder.

#### 4. Opening of e-PADS Bids

Bids will be opened by the Tender Opening Committee of CCRI, Multan, in the presence of bidders or their representatives who choose to attend (their presence is not mandatory). The opening will take place on the date, time and venue mentioned in the detailed schedule provided in the e-tender documents.

#### 5. e-PADS Tender Eligibility Criteria

Bidders are advised to carefully review and comply with these criteria to ensure their eligibility for the e-PADS tender process.

- i. The firm/supplier must be registered with the Securities and Exchange Commission of Pakistan (SECP), Chamber of Commerce or the relevant department/s.
- ii. Valid income tax and sales tax registration with the Federal Board of Revenue (FBR) is required.



- **iii.** The firm/supplier should have a minimum of 3-5 years of experience in providing the specified services. Companies with less than 3-5 years of experience will not be considered.
- **iv.** Submission of verified proof/attested for all the mentioned criteria is mandatory. Non-submission may lead to disqualification of the bidder from further processes.
- v. Manual submission of bid without e-PADS is NOT ALLOEWD.

#### 6. General Terms and Conditions for the e-Bidding

Any offer that is not received as per the terms and conditions laid out in the tender document is liable to be excluded from the competition. Moreover, No offer shall be considered if:

- i. The firm is not registered with the SECP/Chamber of Commerce and Industry.
- ii. Received without valid proof of income Tax/Sales Tax payments for the past year.
- **iii.** Offer received without earnest money.
- **iv.** Tender documents are not signed by the supplier/authorized person(s) and are without the seal of the firm.
- **v.** The offer is ambiguous/unclear.
- vi. The offer is conditional.
- vii. The offer is from a blacklisted firm.
- viii. Offer received with a shorter validity than required.
- **ix.** The offer does not conform to the specifications/requirements indicated in the tender doucments.
- **x.** The acceptance of tender is not communicated in writing by the successful bidder within the validity/stipulated time.
- **xi.** The offer is withdrawn, amended or revised during the validity period of the offer without the approval of the buyer.
- **xii.** The contractor fails to execute the contract strictly in accordance with terms and conditions of the tender.
- **xiii.** The bidder should indicate their National Income Tax & Sales Tax Numbers.
- **xiv.** The Director, CCRI, Multan office would be entitled to deduct all prevailing government taxes before making payments to the firm.
- xv. The qualified bidder is subject to disqualification/termination of contract at any stage of the contract, if the offered goods (Weedicides, Fertilizer and Insecticides) are low quality and OR the bidder firm fails to timely replace such items/goods, which would be affected the cotton crop cultivation.

#### 7. Technical Advice

The Tender Opening Committee will review the bidders' documents to verify their validity and eligibility. The tender committee may seek technical advice from experts with relevant knowledge and experience to evaluate tender offers.

#### 8. Evaluation Criteria

The evaluation of bids will be conducted in two stages:

- i. **Technical Evaluation:** Bidders will be assessed based on their technical capabilities, compliance with eligibility criteria and relevant experience. Only firms/suppliers that meet the prescribed technical requirements will qualify for the next stage.
- **ii. Financial Evaluation:** Financial proposals of only technically qualified bidders will be considered. The lowest bid will not be accepted automatically; the final decision will depend on both technical merit and financial competitiveness.

**Note:** The **Tender Opening Committee** reserves the right to reject the lowest bid if it does not meet the required technical standards at the time of tender opening.



#### 9. Payment to the Firm/Supplier

All payments will be made through crossed cheques in favor of the firm/supplier. Payments will be processed against the invoice for the supplied goods/items, which must be submitted to the Director, CCRI, Multan.

#### 10. Bid Security (Fixed)

To participate in the tender, bidders must deposit a fixed bid security of **Rs. 125,000/-** in the form of a Bank Draft/Pay Order made in favor of the Director, CCRI, Multan. The bid security will be refunded to unsuccessful bidders after the completion of the evaluation process. For the successful bidder, the bid security will be refunded upon the completion of all mandatory procedures leading to the award of the contract.

#### 11. Deduction of Taxes

The office of the Director, CCRI, Multan will deduct income tax and any other applicable taxes as per the notifications issued by the Federal Board of Revenue (FBR) from time to time. Upon request, the Accounts Officer, CCRI, Multan, will provide the firm/supplier with copies of tax payment receipts or challans.

#### 12. Payment of Sales and Other Taxes

The firms/suppliers will be liable to pay government taxes (as per rule) as notified by FBR from time to time.

#### 13. Termination of Contract

- i. The agreement will automatically terminate upon the expiry of the contract period.
- **ii.** If complaints arise regarding the quality of supplied Weedicides, fertilizers and insecticides, the supplier will be given two weeks to address and resolve the issues. This will be done under the formal intimation of the Director, CCRI, Multan. If the supplier fails to resolve the issue within the given timeframe, the contract may be terminated.
- **iii.** The Director, CCRI, Multan, based on the recommendations of the Tender Opening Committee (TOC), reserves the right to terminate the contract at any time for valid reasons. The service provider will be immediately informed in writing about the decision.
- iv. No compromise will be made on delayed supply. The supplier must ensure timely delivery as per the agreed schedule. Failure to meet deadlines may result in penalties or contract termination.

#### 14. Performance Guarantee

- i. The successful bidder must provide a performance guarantee **equal to 10%** of the contract amount to the Director, CCRI, Multan within 15 days of receiving the contract award.
- **ii.** The performance guarantee must be in the form of a Bank Guarantee, CDR (Call Deposit Receipt), Demand Draft (DD), Pay Order or Banker's Cheque issued by a scheduled bank.
- **iii.** This guarantee will be returned after the completion or termination of the contract period, provided all liabilities are cleared by the bidding firm/supplier.
- **iv.** If the supplier fails to meet contractual obligations or does not comply with the procurement order/contract, the performance guarantee will be forfeited.

#### 15. Time Period of the Performance of the Contarct

The tentative time period for the supply of the required goods will be from June 2025 to November 2025.



#### 16. Strict Compliance with Timely Supply

Timely supply, as per the scheduled timeline is of utmost importance and non-negotiable. Any delay in delivery can severely disrupt research activities, hinder progress and compromise the integrity of ongoing projects at the institute. Bidders must ensure strict adherence to the delivery schedule. Failure to supply on time may lead to penalties, contract termination, and forfeiture of the performance guarantee.
