- a) State Bank of Pakistan Banking Services Corporation invites electronic bids (e-Bids) from bidders who are registered with PPRA for e-procurement on "e-Pak Acquisition and Disposal System (EPADS)", having Income & Sales Tax registration and are on Active Taxpayers List (ATL) of FBR.
- b) The e-bidding documents to acquire and renew in-use Adobe Software Licenses as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at <a href="https://portal.eprocure.gov.pk/">https://portal.eprocure.gov.pk/</a>.
- c) Procurement method shall be 'Single Stage Two Envelope Procedure' in line with Rule 36 (b) of the Public Procurement Rules 2004. All e-Bids must be accompanied by Bid Security amounting to PKR 150,000/- in an acceptable form in favor of SBP Banking Services Corporation. The bidders shall upload scanned copy of Bid Security on EPADS. Original Bid Security must be submitted to the Procuring Agency on or before the closing date & time of e-bids submission, failing which the e-bid shall be rejected.
- d) The e-bids, must be submitted by using EPADS on or before **Wednesday**, **07 May 2025 11:00 AM**. Manual bids shall not be accepted. e-Bids will be opened on the same day at **11:30 AM** on EPADS.


